COMMUNITY EMPOWERMENT NETWORK ASSUMPTION OF RISK AND RELEASE OF LIABILITY

This Assumption of Risk and Liability Release Authorization Agreement (the "Agreement") is entered into between the Trip Participant ("Participant") and Community Empowerment Network ("CEN") with respect to CEN's "Unveiling the Amazon" tour to the Brazilian Amazon (the "Tour").

ACKNOWLEDGEMENT AND LIMITATIONS. Participant acknowledges and agrees that:

(1) Participant is in sufficiently good health to undertake the Tour and will be fully responsible for his/her physical condition and well-being during the Tour. Participant should ensure that medical coverage is adequate and up-to-date.

(2) CEN, although not bound to act, reserves the right at any time to refuse to allow a Participant to continue the trip if in the sole opinion of the designated trip leader, health or actions of the Participant would affect the safety, smooth progress or enjoyment of the trip. In the event that such refusal or cancellation becomes necessary, CEN shall not be liable for any refund or for return transportation or any other expense of the Participant. CEN disclaims any responsibility for Participant's health and nothing in this paragraph (2) shall be construed otherwise.

(3) Participants and their personal property including baggage are at all times solely at their own risk. Participants are advised to be sufficiently insured against illness, injury, death and loss or damage to personal property whether on board a vessel, aircraft or on land. Any emergency evacuation expenses and the costs of medical treatment or attention are the responsibility of the Participant.

(4) Any expenses incurred by delays or events beyond the control of CEN are the sole responsibility of Participant.

(5) Risks on the Tour include, but are not limited to, the hazards of traveling in remote terrain, accident or illness in remote places without readily available medical facilities, the forces of nature, the hazards of war, civil insurrection, terrorism and street crime.

(6) Airports, roads, railroads, highways, bridges, buildings and other man-made structures, as well as motor vehicles, aircraft, boats and other conveyances associated with the Tour may not be constructed or maintained up to standards customary in the United States.

(7) Each Participant agrees to permit CEN the right to use photographic records for advertising, promotion or publication.

(8) CEN reserves the right and is hereby authorized by each Participant to alter or cancel the Tour or portions of the Tour in the event of changes in weather or water conditions, mechanical failure, insufficient bookings, or any other reasonable cause. If the Tour is canceled by CEN, all monies received from the Participant will be refunded. Any additional expenses incurred due to a cancellation or alteration of the itinerary will be the responsibility of the Participant, including but not limited to airfare and visa costs.

(9) Parents or legal guardians of minor Participants must co-sign with minor Participants whether or not they themselves are Participants on the Tour, and their signatures represent a full discharge of any claims or legal actions against CEN which may be made or brought by a minor Participant or the parent or legal guardian of a minor Participant

(10) Participant has read, understands and agrees to all provisions contained in this Agreement.

ASSUMPTION OF RISK AND RELEASE OF LIABILITY. Participant acknowledges and understands that participation in the Tour may involve risk of bodily injury or harm (including death and/or dismemberment) to Participant, or may involve risk of harm to the property of Participant. Participant acknowledges that s/he fully understands and appreciates the risk inherent in the Tour, and Participant expressly and without limitation agrees that any and all risks and/or damage or destruction to property is fully and completely assumed by Participant. With a full understanding of the risks involved in the Tour, Participant hereby expressly and completely releases CEN, its officers, directors, employees, agents or representatives from and against all liability, claims, lawsuits, damages or losses of any kind, known and unknown, which may be connected with, resulting from, or arising out of the planning, arranging, implementation of or participation in the Tour by Participant, regardless of whether such liability, claims, lawsuits, damages or losses are caused by the negligence of CEN. This release by Participant shall include all claims, lawsuits, damages or losses of any nature whatsoever, including but not limited to, all claims for bodily injury, personal injury, economic loss and property damage.

INDEMNITY. Participant agrees to defend (including the payment of attorneys fees and costs), indemnify and hold harmless CEN, its officers, directors, employees, agents and representatives from and against any and all losses suffered by CEN, its officers, directors, employees, agents and representatives as a result of any claims, lawsuits or actions arising out of or in any way relating to participation in the Tour by Participant.

BINDING EFFECT OF AGREEMENT. This Agreement shall be binding upon all heirs, successors, representatives and assigns of Participant.

GOVERNING LAW. This Agreement shall be interpreted and construed in accordance with the laws of the State of Washington, without reference to its conflict of laws principles.
